IN 2016, THE ORGANIZATION PROVIDED CLOSE TO 15,000 HOURS OF COMMUNICATION ACCESS SERVICES. DEAF, INC. ALSO HELD NUMEROUS EDUCATIONAL WORKSHOPS TO IMPROVE THE SKILLS OF LOCAL SIGN LANGUAGE INTERPRETERS.
