IN 2019, THE ORGANIZATION PROVIDED 11,660 HOURS OF COMMUNICATION ACCESS SERVICES. DEAF, INC. ALSO HELD NUMEROUS EDUCATIONAL WORKSHOPS TO IMPROVE THE SKILLS OF LOCAL SIGN LANGUAGE INTERPRETERS.

THROUGH THIS SUPPORT, INDIVIDUALS ARE EMPOWERED TO TAKE POSITIVE ACTION IN THEIR LIVES AND UNDERSTAND THEIR COMMUNICATION ACCESS RIGHTS. IN 2019, THE ORGANIZATION PROVIDED DIRECT SUPPORT IN 118 NEW CASES INVOLVING DEAF/HARD OF HEARING INDIVIDUALS AND PROVIDED 7 TRAINING EVENTS TO THE COMMUNITY. THE ORGANIZATION ALSO PRODUCES PUBLIC SERVICE ANNOUNCEMENTS AND RAISES AWARENESS THROUGH USE OF MEDIA AND VISUAL ARTS. IN 2019, THERE WERE 278 INDIVIDUALS WHO ATTENDED SIGN LANGUAGE CLASSES.
